- (5) Any import of animals shall be subject to an Animal and Importation Permit from the Veterinary Services Division, Ministry responsible for Agriculture. Any export permit or re-export certificate shall be subject to the grant of an Export Health Certificate from the Veterinary Services Division, Ministry responsible for Agriculture.
- (6) If the specimens are protected animals / birds taken from the wild in Jamaica provide:
 - (a) exemption from the Minister of Environment and
 - (b) the purpose that the specimen was removed from the wild.
- (7) If the specimens are required for the purpose of re-export, attach copies of cancelled CITES Export Permits or Re-export Certificate issued by the appropriate CITES office in the country from which the animal was imported. If you were not the importer, provide copies of the importer's documents and the invoice or receipt that shows you purchased the animal from the original importer.
- (8) For living wildlife, describe the type, size and construction of any shipping container and arrangement for caring for the animal(s) during transport.
- (9) For CITES Appendix I species, attach a copy of the CITES Import Permit issued by the Management Authority of the importing country.
